HADO Event Office

Entry Regulations

Entry Requirements

- The teams which follow the rules and regulations of the event as well as the directions given by the event office.
- The teams which agree to shooting and media exposure at the event.
- The teams which meet the requirements to be set by each competition.

The Fundamental Rules of HADO

Length of a Match

- 80 seconds per match

Winning and Losing

- The team earning more points than the other at the end of the competition takes the match.

Overtime Match

- When the score is tied, overtime is given 10 seconds after the end of the match, when the team to earn the first point becomes a winner.

Entry

- Player needs to be ready for the match with the individual skill parameter customized for his use within 30 seconds after wearing the devices.
 - ※ Player needs to register for HADO connect or focus the device properly in advance before customizing the parameter (before exchanging bows).
- Should player fail to be ready for the match within the given time, he needs to leave the court as soon as the game starts

Win/Loss by Default

- When a team is not ready for the match in time, the other team wins the game by default. The winner earns additional 5 points, while no point is given to the loser.

Rematch

- If the following events arise, referee may call a halt to the match and offer a rematch.
 1. In case that the device doesn't work well due to low battery charge.
 2. In case that the device doesn't work properly due to setting errors.
 3. In case that the application program is shut down for some reason. (excluding the case that the player is responsible for the cause)
 4. In case that the device is broken. (excluding the case that the player is responsible for the cause)
 5. In case that players are interrupted by influences from outside the court.
 6. In case that we find any difficulty in continuing the match due to unforeseen circumstances.
- It is only a referee being able to make a judgement on whether to cancel the game and provide a rematch. For any reason, players are not given a right to stop the game.
- If the following events arise, players may make a request for a rematch to a referee when the match ends. The referee may accept the request only if the following event is confirmed.
 1. In case that the device doesn't work well due to low battery charge.
 2. In case that the device doesn't work properly due to setting errors.
 3. In case that the application program is shut down for some reason. (excluding the case that the player is responsible for the cause)
 4. In case that the device is broken. (excluding the case that the player is responsible for the cause)
 5. In case that players are interrupted by influences from outside the court.
 - ※ Players are not allowed to ask for a stop during a match.
- If the match is interrupted and stopped by a player, referee may make a judgment as to which team takes the match or which penalty is given.
- Any substitution is not allowed for a rematch. (Changing the parameter skills is allowed.)

Leaving the Court During a Match

If player gets injured during a match, he is allowed to leave the court immediately. Once the player leaves the court, he is not allowed to get back into the match and use the skills.

Fouls/Misconducts and Penalties

Below are the fouls and misconducts in HADO for which referee may impose a penalty:

Fouls and Misconducts	Penalties
The act that player intentionally makes himself undetected by AR marker	Warning
The act that player drags or wobbles AR marker intentionally	Warning Receiving two yellow cards during a match brings a 0-10 loss to the team
The act that player makes a physical contact with opponents across the court	Warning Receiving two yellow cards during a match brings a 0-10 loss to the team
The other acts which referee, and the event official deem inappropriate for continuing the match	The act brings a 0-10 loss to the team Referee may judge as the situation demands

Overline Penalties

Players are unable to charge and use their skills while the system detects that your HMD is stepping over the lines in the court. Referee may impose an additional penalty on malicious acts such as a long time or undoubtedly intentional overstep.

Other Prohibitions

- Fixing, bribery, or other equivalent acts.
- The act of slander or violence against other players, teams, sponsors, or the event office, or against the public order and morals.
- The act of intentionally damaging or destroying of a part of the facility or equipment.
- The act that implies the involvement in private gambling.
- Other acts that disobedient to the directions from the event office, which may hinder smooth

operation of the event.

Event Overview

Competition Format

【Preliminaries】

All the participating teams are divided into two groups to play against each other in the round robin preliminaries.

【Finals】

The two teams earning the top spot in the round robin battle against each other in the finals.

※A drawing is held by the event office to determine the group placements for the preliminary round

How to Determine the Ranking of the Teams for the Competitions

【Preliminaries】

At the end of every match in the preliminaries, the ranking of the teams is determined as the team earning more points is placed in a higher rank. If two or more teams in the same group finish even on points, the ranking is determined by the difference between points scored and points allowed. If the teams still remain tied, the steps to break the tie are as follows --to score the most points in all the matches the team play, to win a head-to-head competition, and then to determine by a drawing held by the event office.

【Finals】

The team winning more of the following matches takes the championship title.

Rules of Competitions

Size of the Court

6m-10m long and 6m-7m wide

Rules of Competitions

- Two teams play the seven matches in the same order as in the following list. The more matches the team takes, the more points they gain. The team winning more matches is given additional one point.
- 100 seconds are given between the matches for player substitutions and status changes. Each team may make a request one time for an extension of the time to 200 seconds. In that case, the team needs to notify a referee within 30 seconds after the previous match. Even if the two teams make a request at the same time, an extension of the time to 400 seconds is not allowed.
- Each team needs to hand in the team rosters for the full matches in advance. The event office announces the lineup of the players right before the match.
- No substitution of players is allowed after the announcement nor during the match.
- Referee checks player's status 15 seconds before the matches of 2,4, and 6 as below.

Order of Match	Format of Match
1	3vs3 Regular rules are applied
2	3vs3 The scale for Energy ball should be 1
3	2vs2 Regular rules are applied
4	2vs2 The scale for Shield should not be lower than 8 altogether in the team
5	1vs1 Regular rules are applied
6	3vs3 The total status in the team should be 20 or lower
7	3vs3 Regular rules are applied

Rules for Cancellation of the Event

Below are the rules for cancellation of the event owing to either “force majeure” or “an act by the event office.”

① Cancellation of the event due to force majeure

Before the Beginning of the Event

【Causes】

1. When the weather is rough (with a warning of excessive precipitation, heavy snow, or thunderstorm).
2. When a severe weather is forecasted.
3. When a serious incident such as a traffic hazard, a large-scale disaster, a turbulence, a conflict, a war, a nuclear disaster, a regional scale power outage, or other events equally influential arise.
4. When other incidents equivalent to the aforementioned arise.

【Actions and Steps】

1. The event office determines whether to cancel the event at least one hour before the event begins and inform a representative of each team of the cancelation.
(Please note that the cancelation may be determined at the last minute of the scheduled time of the event in case of sudden worsening of weather.)
2. The event office offers a full refund of the entry and administrative fees.
(It may require a few weeks to complete the refund.)
3. Any claims for compensation for the fees of transportation, accommodation, correspondence, or other related matters will never be accepted.

After the Beginning of the Event

【Causes】

1. When the weather is rough (with a warning of excessive precipitation, heavy snow, or thunderstorm).
2. When a severe weather is forecasted.
3. When a serious incident such as a traffic hazard, a large-scale disaster, a turbulence, a conflict, a war, a nuclear disaster, a regional scale power outage, or other events equally influential arise.
4. When a medical emergency such as a participant's sudden illness or injury occurs, and we place treating the case ahead of proceeding with the event or keeping on the schedule of the event.

5. When other incidents equivalent to the aforementioned arise.

【Actions and Steps】

1. The event office determines whether to cancel or adjourn the event or alter the program by considering the circumstances.
2. A refund of the entry fee or suggestion for an alternative date is not offered in principal.
3. Any claims for compensation for the fees of transportation, accommodation, correspondence, or other related matters will never be accepted.

② Cancellation of the Event due to an Act by the Event Office

Before the Beginning of the Event

【Causes】

1. When the venue's safety hazard which is not expected to be solved prior to the start of the event arises.
2. When other incidents equivalent to the aforementioned arise.

【Actions and Steps】

1. The event official determines whether to cancel the event at least 24 hours before the start time of the event and inform a representative of each team of the cancellation.
(Please note that the cancellation may be determined at the last minute of the scheduled time of the event in case that an unexpected incident occurs.)
2. The event office offers a full refund of the entry and administrative fees.
(It may require a few weeks to complete the refund.)
3. Any claims for compensation for the fees of transportation, accommodation, correspondence, or other related matters will never be accepted.

After the Beginning of the Event

【Causes】

1. When a safety hazard in the venue occurs.
2. When a medical emergency such as the event staff's sudden illness or injury makes it difficult to proceed the event.

3. When other incidents equivalent to the aforementioned arise.

【Actions and Steps】

1. The event official determines whether to cancel or adjourn the event or alter the program by considering the circumstances.
2. The event office offers a full refund of the entry and administrative fees in case of the cancelation of the event. (It may require a few weeks to complete the refund.)
3. Any claims for compensation for the fees of transportation, accommodation, correspondence, or other related matters will never be accepted.

Action Against the Destruction or Damage Caused by an Event Participant

The event office demands a full compensation for one's damaging or destruction of a part of the facility or equipment to repair the damage or purchase the replacement.

Penalties

- When the event office regards one's act as a violation of the rules and regulations of the event, a penalty shall be imposed on the player.
- In ascending order of the severity, the player is given the penalties of a warning, deduction of the points the team scored, a loss of the game, disqualification of the event, suspension of any event entries for a certain period of time, or indefinite suspension of any event entries, all of which are determined by the event office by considering the viciousness and seriousness.
- When a player violates the rules and regulations of the event repeatedly, a more severe penalty is imposed on him.
- The details of the penalties imposed on the players can be disclosed on the official website.
- A player becoming disqualified from playing at the event due to the penalty imposed on him has no right to receive a prize for the winners.

Note

- A mistake in the registration may prevent you from joining the event. You are recommended to make a registration by yourself.
- A consent from his parent or guardian is required for a minor's entry and participation in the event. The event office sees a minor's entry and participation to be agreed by his parent or guardian. Without the consent, those under age are not allowed to join the event.
- Please be advised that there may be restrictions on the outfits and accessories that players can wear for the convenience of the venue.
- Please go to the reception within the reception time of the event. The team which fails to make it in time becomes disqualified from joining the event.
- All the teams participating in the event are requested to stay in the venue until every match end.
- The time schedule is unveiled on the day of the event. We kindly ask you to be punctual so that the event can be finished on schedule.
- Please consult with a staff of the event if you are in a wheelchair or with special needs.
- Please follow the directions from a staff of the event in the venue. You may be asked to leave when disobeying our directions.
- The event office and the facility do not take any responsibility for an accident or theft that you are involved in inside and outside of the venue. Please keep valuables in your possession at the event.
- Please follow the rules of the facility regarding smoking, drinking, and eating in the venue.
- You are not allowed to bring dangerous substances or alcohol beverages into the venue as well as to join the event after drinking or under the influence of drink.
- Please be advised to keep yourself in good shape and do not push yourself too hard for the event.
- Please be advised that any new restrictions may be placed at the event depending on the situations to prevent any accident or disturbance.
- We may have to decline the entry of any players who the event office judges are not suitable for the event to eliminate safety concerns.
- Please be careful when playing with a pair of glasses not to break them. You are recommended

to wear contacts, whereas there is little problem to play without glasses for the short-sighted players.

Handling of Privacy Policy
